Select Committee to consider iCAN ANZ petition to parliament

This update is to let you know that the iCAN ANZ petition will be considered by a parliamentary Select Committee next month. The petition calls on the New Zealand government to actively engage with like-minded governments committed to abolishing nuclear weapons to launch, without delay, an initiative to start the process of negotiating a Nuclear Weapons Convention.

This means we need to have all signatures on the petition returned to us by **15 March** - the petition is available at http://www.icanw.org.nz and a copy is attached for your convenience, please collect as many additional signatures as you can over the next few weeks, thank you.

Although the Select Committee has not called for public submissions, iCAN ANZ can provide letters of support from other organisations as supplementary evidence. • Report from International iCAN: 'Towards a nuclear weapons ban'

Three-quarters of all nations support UN Secretary-General Ban Ki-moon's proposal for a treaty to outlaw and eliminate nuclear weapons, according to a study released in January by the International Campaign to Abolish Nuclear Weapons (iCAN). The iCAN study shows that every nation in Latin America, the Caribbean and Africa is in favour of a treaty banning nuclear weapons, as are most nations in Asia, the Pacific and the Middle East. Support is weakest in Europe and North America, particularly among members of the NATO nuclear alliance. Nations that support a ban on nuclear weapons make up approximately 81% of the world's population. Only 26 nations are opposed to such a treaty, with 22 sitting on the fence.

Call for action to abolish nuclear weapons

To the House of Representatives:

Since the detonation of the first atomic bomb in July 1945, the threat of use of nuclear weapons has cast a shadow over the future of the earth. Since then, each stage of the production of nuclear weapons has caused immeasurable harm to human health and wellbeing, and extensive contamination of the environment - from uranium mining, processing of radioactive materials, manufacturing of nuclear warheads, through to nuclear bomb testing.

Despite ongoing widespread public opposition to nuclear weapons, and the overwhelming majority of governments around the world now supporting the abolition of these weapons of mass destruction, little progress has been made - 20,530 nuclear warheads remain in the arsenals of eight nuclear weapons states.

Yet other weapons of mass destruction - chemical and biological weapons - have been banned by international law, as have some 'indiscriminate weapons' such as anti-personnel landmines and cluster munitions.

In 1987, the New Zealand government took a leading nuclear disarmament role by passing the New Zealand Nuclear Free Zone, Disarmament and Arms Control Act to ban biological and nuclear weapons here. New Zealand was one of six governments that led the Oslo Process to ban cluster bombs which resulted in the 2008 Convention on Cluster Munitions, hosting a key meeting in Wellington as part of the process. It is time for the government to now take a leading role in achieving a Nuclear Weapons Convention.

We therefore respectfully call on the House of Representatives to urge the government to actively engage with 'like-minded' governments committed to abolishing nuclear weapons to launch, without delay, an initiative to start the process of negotiating a Nuclear Weapons Convention - a treaty to prohibit the development, production, testing, deployment, stockpiling, transfer, threat of use, and use of nuclear weapons.
