## **Season's greetings, child rights review, highlights, new initiatives, Peace Scholarships, holiday arrangements, and thank you**

Kia ora,

This message is to wish you a very happy Solstice, Christmas and New Year. It includes information about our forthcoming backgrounder on the review of NZ's compliance with the Convention on the Rights of the Child, a brief outline of some of the highlights of 2010 and new initiatives planned for 2011, a reminder about the White Poppy Peace Scholarships, our thanks for your support during this year, and details of Peace Movement Aotearoa's office and other arrangements during December and January. ### **\* Review of NZ's compliance with the Convention on the Rights of the Child**

In January 2011, the UN Committee on the Rights of the Child will be considering the government's compliance with the Convention on the Rights of the Child (UNCRC) and its two Optional Protocols - on the involvement of children in armed conflict (OPAC), and on the sale of children, child prostitution and child pornography. Action for Children & Youth Aotearoa and Save the Children have submitted comprehensive NGO reports covering a range of UNCRC rights, and Peace Movement Aotearoa has provided information to the Committee on the increasing militarisation of children and their education, in relation to the UNCRC and OPAC.

We are currently finalising a backgrounder with information about the UNCRC, the Optional Protocols, the Committee, the process of consideration of state party reports, the government's report, and the parallel NGO reports. ### **\* Some of the highlights of 2010**

As always, the main highlight of this year has been meetings and discussion with our members and supporters in different parts of the country and overseas, visitors to the office, as well as email discussion, phone calls, and sometimes letters from those who we didn't have an opportunity to meet in person. We also enjoyed productive collaboration with a range of organisations on many areas of our work.

Particular highlights of our international work were our involvement in the UN Human Rights Committee's consideration of the government's Periodic Report under the International Covenant on Civil and Political Rights, in particular working with the Aotearoa Indigenous Rights Trust

around the NGO briefings to the Committee and seeing some of our recommendations included in the Committee's Concluding Observations, and the Press Council ruling in our favour on the NZ Herald's coverage of the Committee; as well as the visit of the UN Special Rapporteur on Indigenous Peoples.

Among the highlights of our national work were: our enjoyment in taking part and advertising many peace related meetings, seminars, and conferences in different parts of the country, including the 2010 National Peace Workshops which were hosted by the Quaker Settlement; supporting Waihopai Ploughshares, especially during the nine days of the trial and the 'not guilty' verdict; doing the administration work for the White Poppy Peace Scholarships which were awarded for the first time this year, and receiving the first Peace Scholarship dissertation; further developing our topic focused e-lists which have provided much valuable feedback and discussion; receiving an official apology from the Ministry of Defence about their misrepresentation of our submission on the Defence Review; our complaint to the Office of the Ombudsmen about the Ministry of Justice's refusal to release information we requested about decisions on the foreshore and seabed legislation, which not only resulted in our receiving the information, but also in the public release of the responses to the Consultation Document; working with students at the National Centre for Peace and Conflict Studies; and far too many other things to list here. #### **\* New initiatives in 2011**

Among the new initiatives we have planned for 2011 are: finalising the establishment of ICAN (International Campaign to Abolish Nuclear Weapons) Aotearoa New Zealand following the national nuclear abolition coordination meeting in Auckland last month; launching the new web page with resources for the lobbying around the first reading of the Depleted Uranium (Prohibition) Bill in collaboration with DUET; providing information for the preliminary consideration of the government's Periodic Report under the International Covenant on Economic, Social and Cultural Rights; and revamping our web site, if we can find funding for that.

And of course, in the coming year, we will continue to work on all of the ongoing topics and issues we are currently working on; particular focuses will include the recently announced SIS Amendment Bill and the constitutional issues review - there are already pages with information about both on our site. The date, place and focus of the 2011 National Peace Workshops will be finalised early next year.
